India's Sustainable Fashion Landscape- A New Chapter's Begins with IFBEC's Round Table

The International Fashion Business Exchange Council (IFBEC) laid the foundation of India's emergence as the Fashion Business Capital of the world with an exclusive Round Table discussions on "India's Sustainable Fashion Business Landscape", the event was organised at SASMIRA, Mumbai held on 30th August 2024. The International Fashion Business Exchange council (IFBEC) is not-for-profit organization dedicated to creating business exchange opportunities for fashion and lifestyle industry worldwide. IFBEC focuses on developing and connecting a diverse range of stockholder, including entrepreneurs, brands, corporates, associations, government entities, educational institutes, NGO's, communicators, innovators, and recyclers.

IFBEC's mission is to bring together these stakeholder's to drive sustainable and responsible manufacturing practices within the Textile Industry. The Round table discussions focused on priorities like shifting consumption patterns, improved practices and infrastructure investment crucial for driving sustainability within the fashion industry. Eminent Leaders underscored the importance of aligning efforts across the textile value chain, particularly within the MSME sector, which features a largely distributed chain. The discussion highlighted that a key driver of sustainable change would be a 'demand pull' mechanism, where brands and fashion houses prioritize ecology over economy, thus reinforcing the application of sustainability principles in manufacturing across the fibres along the textile value chain.

TEXTILE: Market Highlights

India-Knitting Future

- India is among the world's largest producers of Textiles and Apparel

- The domestic apparel & Textile industry in India contributes approx. 2.3% to the country's GDP, 13% to industrial production and 12% to exports. India has a 4% share of the global trade in textiles and apparel. (FY-2023-24)
- ❖ India is one of the largest producers of cotton and jute in the world. India is also the 2nd largest producer of silk in the world and 95% of the world's hand-woven fabric comes from India. Currently, India's textile exports are at \$36 Bn and are projected to reach \$100 billion by 2030.
- ❖ The textiles and apparel industry in India is the 2nd largest employer in the country providing direct employment to 45 Mn people and 100 Mn people in allied industries.
- ❖ India has also become the second-largest manufacturer of PPE in the world. More than 600 companies in India are certified to produce PPEs today, whose global market worth is expected to be over \$92.5 Bn by 2025, up from \$52.7 Bn in 2019.
- India is set to achieve \$250 Bn textiles production and \$100 Bn exports by 2030.
- The domestic apparel & textile industry in India contributed to 2% to the country's GDP, 7% of industry output in value terms. (FY-2023-24)
- ❖ India has a 4.6% share in global trade of textiles & apparel along with a 10.5% share in India's overall export basket. (FY-2023-24)
